Overview:

The U.S. Courts, Fifth Circuit, is composed of the federal courts in Louisiana, Mississippi and Texas, and is the second largest circuit in the federal system. The Circuit Executive's Office provides support services, including support services related to space and facilities, to more than 200 appellate, district, bankruptcy, and magistrate judges within the nine judicial districts of the circuit.

Representative Duties:

This position reports to the Assistant Circuit Executive (ACE) for Space and Facilities and performs design/construction project management related duties on behalf of judges, court unit executives, and other judiciary staff. The position will manage the Fifth Circuit's Capital Security Program (CSP) projects. The CSP is a collaborative initiative of the U.S. Courts, U.S. Marshals Service, and General Services Administration (GSA) to improve security features in federal courthouses.

Duties include:

- Review architectural and engineering drawings, specifications, schedules, cost estimates, shop drawings, and other project related documents.
- Participate in on-site meetings, conference calls, and web meetings.

- Prepare written meeting summaries, briefing memos, inspection reports, and other project related documents.
- Communicate orally and in writing the progress of CSP projects to the ACE, judges, unit executives, and other judiciary clients.

Qualifications and Requirements:

The position requires:

- Bachelor's or master's degree in architecture
- Availability for travel, primarily within the circuit (Louisiana, Mississippi, and Texas)
- Availability for after-hours and weekend work
