Overview:

The U. S. Courts, Fifth Circuit, is composed of the federal courts in Louisiana, Mississippi and Texas, and is the second largest circuit in the federal system. The Circuit Executive's Office provides support services, including support services related to space and facilities, to more than 200 appellate, district, bankruptcy, and magistrate judges within the nine judicial districts of the circuit.

Representative Duties:

This position reports to the Assistant Circuit Executive (ACE) for Space and Facilities and performs architecture and facilities' related duties for the ACE, judges, court unit executives, and other judiciary staff. Duties include:

- Prepare design intent drawings and presentation materials.
- Prepare project budgets and schedules.
- Oversee architectural/engineering firms and contractors performing work for the court.
- Review architectural and engineering drawings, specifications, schedules, cost estimates, shop drawings, and other project related documents.
- Participate in on-site meetings, conference calls, and web meetings.

- Prepare written scopes of work, meeting summaries, briefing memos, inspection reports and other project related documents.
- Communicate orally and in writing progress of court projects to judges, unit executives, and other judiciary clients.
- Track and report on facilities repair projects.
- Maintain facility assignment plans using AutoCAD.

Qualifications and Requirements:

The position requires:

- Bachelor's or master's degree in architecture
- Three years minimum experience as a registered architect
- Availability for travel, primarily within the circuit (Louisiana, Mississippi, and Texas)
- Availability for periodic after-hours and weekend work
