Appealing the Judgment in a Criminal Case, Chris Richard Drew raises arguments that are foreclosed by <u>United States v.</u> <u>McCarty</u>, 36 F.3d 1349, 1361 (5th Cir. 1994), which held that the Double Jeopardy Clause does not bar punishments under both 18 U.S.C. §§ 924(c) and 2113(a) and (d). The Government's motion for summary affirmance is GRANTED, and the judgment of the district court is AFFIRMED.
