to this attempt at an appeal. Accordingly, this appeal must be and is DISMISSED.

litigation, except where the district court has certified the order for appeal under Fed. R. Civ. P. 54(b). See Thompson v. Betts, 754 F.2d 1243, 1245 (5th Cir. 1985) (an order dismissing fewer than all of the parties is not appealable absent Rule 54(b) certification).
