Appealing the judgment in a criminal case, Chevis Alleon Hall presents arguments that he concedes are foreclosed by *United States v. Daugherty*, 264 F.3d 513, 518 (5th Cir. 2001), which rejected a Commerce Clause challenge to the felon-in-possession-of-a-firearm statute, 18 U.S.C. § 922(g), and *United States v. Dancy*, 861 F.2d 77, 81-82 (5th Cir. 1988), which held that a conviction under § 922(g) does not require proof that the defendant knew that the firearm in his possession had an interstate nexus and that he was a felon. In addition,

Hall presents arguments that he concedes are foreclosed by *United States v. Rose*, 587 F.3d 695, 705-06 & n.9 (5th Cir. 2009), *cert. denied*, 130 S. Ct. 1915 (2010), which held that *Flores-Figueroa v. United States*, 129 S. Ct. 1886 (2009) did not alter the proof required in a § 922(g)(1) case. Accordingly, the Government's motion for summary affirmance is GRANTED, its alternative motion for an extension of time to file a brief is DENIED, and the judgment of the district court is AFFIRMED.
