PER CURIAM:*

Ofelia Pacheco-Martinez appeals her sentence following her guilty plea conviction for illegal re-entry after deportation in violation of 8 U.S.C. § 1326. Pacheco argues that her sentence should not have exceeded the two-year maximum sentence under 8 U.S.C. § 1326(a). Pacheco acknowledges that her argument is foreclosed by <u>Almendarez-Torres v. United States</u>, 523 U.S. 224 (1998), but she seeks to preserve the issue for Supreme Court review in light of <u>Apprendi v. New Jersey</u>, 530 U.S. 466 (2000).

Pacheco's argument is foreclosed by <u>Almendarez-Torres</u>, 523 U.S. at 235.

The Government has moved for a summary affirmance in lieu of filing an appellee's brief. In its motion, the Government asks that the judgment of the district court be affirmed and that an appellee's brief not be required. The motion is granted.
