Carlos Sosa-Hernandez petitions for review of an order of the Board of Immigration Appeals (BIA) holding that Sosa-Hernandez's state conviction for felony driving while intoxicated was an aggravated felony warranting his removal from this country. The respondent has moved to dismiss the petition for review and to remand the case to the BIA for reconsideration in light of <u>United States v. Chapa-Garza</u>, 243 F.3d 921, 927 (5th Cir. 2001). Sosa-Hernandez has not replied to the respondent's motion to remand.
