This matter is before us on remand from the Supreme Court for reconsideration in light of its recent opinion in <u>United States v.</u> <u>Booker</u>.¹ At our request, the parties have commented on the impact of <u>Booker</u>. For the following reasons, we conclude that <u>Booker</u> does not affect Defendant-Appellant Juan Manuel Castor-Lozano's sentence.

I. BACKGROUND

Castor-Lozano pleaded guilty to reentering the United States illegally following removal, in violation of 8 U.S.C. § 1326, an

offense that is punishable by up to two years imprisonment. At his sentencing — which occurred prior to <u>Booker</u> — the district court increased Castor-Lozano's offense level under the then-mandatory Sentencing Guidelines by 16 levels, because he had a prior aggravated felony conviction. Following the Guidelines, the court sentenced Castor-Lozano to 46 months imprisonment. Castor-Lozano then appealed his sentence, arguing that it violated the Fifth Amendment's Due Process Clause. After we affirmed in an unpublished opinion,² Castor-Lozano petitioned the Supreme Court for a writ of certiorari, asserting his <u>Booker</u> claim for the first The Supreme Court vacated our judgment and remanded to us time. for reconsideration in light of <u>Booker</u>.³ We again affirm Castor-Lozano's sentence.

II. DISCUSSION

A. Standard of Review

Castor-Lozano raised his <u>Booker</u> claim for the first time in his petition for a writ of certiorari. We will therefore review his <u>Booker</u> claim only in the presence of "extraordinary circumstances."⁴ Although we have yet to flesh out the contours of precisely what constitutes "extraordinary circumstances," we know that the extraordinary circumstances standard is more onerous than

the plain error standard.⁵ If, therefore, Castor-Lozano cannot meet the requirements of plain error review, he certainly cannot satisfy the requirements of extraordinary circumstances review. So, despite the fact that Castor-Lozano argues that the extraordinary circumstances standard is inapplicable in this case for a variety of reasons, because — as Castor-Lozano concedes he cannot meet even the lower plain error standard, we need not address his arguments.

Under plain error review, we will not remand for resentencing unless there is "(1) error, (2) that is plain, and (3) that affects substantial rights."⁶ If the circumstances in a case meet all three criteria, we may exercise our discretion to notice the error only if it "seriously affects the fairness, integrity, or public reputation of judicial proceedings."⁷ Under <u>Booker</u>, a district court's sentencing of a defendant under mandatory Sentencing Guidelines (1) constitutes error that (2) is plain.⁸ Whether the error affects substantial rights is a more complex inquiry for which the defendant bears the burden of proof. He will carry this burden only if he can "show[] that the error 'must have affected the outcome of the district court proceedings.'"⁹ That may be

shown, in turn, by the defendant's "demonstrat[ing] a probability 'sufficient to undermine confidence in the outcome.'"¹⁰ To demonstrate such a probability, the defendant must identify in the record an indication that the "sentencing judge — sentencing under an advisory [Guidelines] scheme rather than a mandatory one would have reached a significantly different result."¹¹

B. Merits

In his supplemental letter brief, Castor-Lozano concedes that "<u>Mares</u> appears to foreclose [his] plain-error claim in this circuit." Specifically, Castor-Lozano is unable to point to any indication in the record that there is a probability that the sentencing judge would have sentenced him differently under an advisory Guidelines scheme. Instead, he preserves a challenge to the standard of review we adopted in <u>Mares</u>, arguing that in <u>Mares</u> we got it wrong and the plain error standard employed by other courts (the Sixth Circuit, for example¹²) gets it right. <u>Mares</u> is the settled law of this circuit, however, and we may revisit it only <u>en banc</u> or following a Supreme Court decision that actually or effectively overturns it. Accordingly, we affirm the sentence imposed by the district court below.

III. CONCLUSION

As there exist no extraordinary circumstances or other grounds for relief, Castor-Lozano's sentence is affirmed. We therefore need not address the government's pending Motion to Reinstate Prior Affirmance of Appellant's Conviction and Sentence in Lieu of Filing Supplemental <u>Booker</u> Brief.
