PER CURIAM:*

Katch Kan USA, L.L.C. seeks review of a National Labor Relations Board order finding that it engaged in an unfair labor practice when it fired Tanner Siems. Katch Kan maintains that it terminated Siems because he refused an assignment to Saudi Arabia. The Board, however, adopted the finding of an administrative law judge who concluded that the termination was retaliation for Siems's engaging in protected activity just eleven days before he

was fired. The protected activity involved participation in a work stoppage that protested a significant change in Katch Kan's compensation system.

The standard of review decides the outcome of this appeal. We must enforce the Board's order so long as it is supported by substantial evidence, which we have described as evidence that is "relevant and sufficient for a reasonable mind to accept as adequate to support a conclusion." *El Paso Elec. Co. v. N.L.R.B.*, 681 F.3d 651, 656–57 (5th Cir. 2012) (internal quotation marks and citation omitted). Having reviewed the record, briefs, and arguments of counsel, we conclude that substantial evidence supports the Board's order.

Katch Kan's petition is DENIED. The Board's order is ENFORCED.
