PER CURIAM:*

Eric Flores, Texas prisoner # 2051801, moves for in forma pauperis (IFP) status to appeal the district court's dismissal of his 42 U.S.C. § 1983 complaint on the basis of the three-strikes bar in 28 U.S.C. § 1915(g). However, as there is no timely notice of appeal in this case, we lack jurisdiction to consider Flores's claims. *See Bowles v. Russell*, 551 U.S. 205, 214 (2007). Accordingly, this case is DISMISSED with prejudice. Flores's motion for IFP is DENIED.
