We have reviewed counsel's brief and the relevant portions of the record reflected therein, and determine that "counsel has diligently investigated the possible grounds for appeal." *Anders*, 386 U.S. at 742. We agree with counsel's assessment that Mayorga-Castillo can raise no nonfrivolous issue on appeal challenging either his guilty plea or his sentence.
