The district court dismissed the suit as barred by res judicata, reasoning that the claim asserted in this suit should have been raised in the third suit that was dismissed earlier.

The district court had diversity jurisdiction over the earlier suit and this suit. The claim asserted in this suit is based on the same nucleus of operative facts as the claim asserted in the third suit. All elements for the application of res judicata are present.¹

For these reasons and the careful reasons advanced by the magistrate judge on August 7, 2018 and those of the district judge on August 23, 2018, the judgment appealed from is AFFIRMED.

¹ A claim is barred by res judicata if: "(1) the parties are identical or in privity; (2) the judgment in the prior action was rendered by a court of competent jurisdiction; (3) the prior action was concluded by a final judgment on the merits; and (4) the same claim or cause of action was involved in both actions." *Test Masters Educ. Servs., Inc. v. Singh*, 428 F.3d 559, 571 (5th Cir. 2005).
