This service is not available for any pro se serving in confinement.

OPTION #2 - FILE DOCUMENTS ELECTRONICALLY AND RECEIVE COPIES OF FILINGS, COURT NOTICES, AND COURT ORDERS ELECTRONICALLY.

If you want to file documents electronically in your case, you must first file a motion with the court and the court must grant your request.

To apply:

- 1. Prior to filing the motion, parties should visit the ECF Information page and review reference materials to be familiar with how to e-file. All parties filing motions must also conduct a conference with all parties regarding the motion, the filer must contact all parties, advise what the motion will seek and ask each if they are opposed or unopposed to the motion.
- 2. If the court grants your motion, follow the steps above in OPTION #1 to create a PACER account and submit a request to the Fifth Circuit for an e-filing account, if you have not already done so.

If you have already completed the steps in OPTION #1, no further action is needed. You may log in and file with this court in the approved case.

3. If the court denies your motion to file documents electronically, you may still apply to receive notification of filings and orders by email as detailed in OPTION #1 if you have not already done so.

Filing Instructions for the Pro Se Mailbox:

- You must put your case number in the subject line of your email

- You may only attach one pdf document in an email. Send two emails to send your brief and record excerpts, for example.

- You may not use the email to ask questions. If you have any questions, call 504-310-7700

- If you need to correct a filing, you must file a motion to correct the filing.

- Documents in support must be filed the same date as the initial filing.

- You must serve the opposing side

Notices of Docket Activity (NDA) from the Court

Pro Se parties who sign up for electronic service (a CM/ECF account) and attorneys of record with CM/ECF account will receive all notices of all filings via email. Registration for CM/ECF, consents the user to e-service and removes the user from receiving paper service.

Not all CM/ECF accounts will have the ability to file documents, but all parties or attorneys with CM/ECF accounts will ONLY receive electronic service of filings from the court. Pro Se parties wishing to also have the ability to electronically file are addressed in Option #2 of the Electronic Noticing and Filing Options Available to Pro Se Parties Guide.

The notice will always provide the date and time of the transaction on the docket, followed by the case name, case number and then any associated documents. Clicking the blue "Documents" link is essential to receiving all pertinent information associated with the notice.

The Notice will never have attachments, the documents instead are "linked" to the email. Each person who receives the email is only granted ONE free click on the document link and that free click must be made within 14 days of the notice date.
