Period of Performance: Delivery and installation should be scheduled Monday – Friday between the hours of 9:00 a.m. – 4:00 p.m. tentatively starting February, 2022 and completion no later than March 31, 2022. The contractor is required to coordinate delivery and installation schedule with Beth Raymond or Sue Creech. Advance notice is required to ensure tenants can adequately prepare the space for work.

#### 7. Requirements:

A. Quote

- a. Vendor shall provide an itemized pricing quote for the furniture listed on the attachments to this RFQ. A purchase order will be generated and emailed to the awarded vendor.
- b. Products on these attachments are listed with a reference image, specifications and name brand. Images and name brands are to be used as an "Equal" for reference purposes only and do not represent the actual product.
- c. Vendor shall provide power/data requirements and specifications for any furniture that need(s) or require(s) power/data resources.

- d. All leather and fabric should be mid grade and will be chosen at time of award.
- e. All finishes should be mid grade and will be chosen at time of award

### B. Deliverables

# a. Manufacturer's Data:

Prior to fabrication, submit manufacturer's technical data, dimensioned drawings, color and finish samples, product photographs, product data and installation instructions for each item of furniture. Submit complete operating and maintenance data.

Samples:

Submit samples of each finish and color selected. Minimum sample size for fabric: 4" x 4"; for finishes: 2" x 2". Samples to include finishes and colors on the following surfaces: Seating Fabric Wood and wood veneers

Plastic laminate and matching edge Metal finishes

C. Furniture delivery and installation

- a. Vendor must protect doors, doorway, corridor walls and elevator walls during installation. The contactor is responsible for repair of these areas for any damage caused by contractor.
- b. Vendor must protect units and finishes from damage during shipping, storage, handling, installation, and construction of other work in the same area.
- c. Vendor must wrap and crate each item for protection from damage.
- Any defects in material from installation shall be repaired or replaced to The Courts' satisfaction. Furniture that cannot be satisfactorily repaired shall be replaced without extra cost to The Courts.
- e. Vendor must assemble/install all furniture complying with the manufacturer's installation instructions.
  f. Where applicable, vendor must securely anchor units; align adjoining units.
- g. Vendor must ensure operating parts work freely and fit neatly. h. Vendor must adjust hardware and catches as required.
- i. All packaging material and debris shall be removed from site and properly disposed by awarded vendor daily.
- j. Keying should be completed and tested for proper installation.

C. Closeout Plan and Deliverables:

- a. Vendor shall provide a punch list summary within five (5) business days of furniture installation completion.
- b. Final punch list completed and approved by the Circuit Librarian.
- c. Upon completion of installation and prior to final walkthrough with court staff, vendor shall professionally clean furniture and leave area ready for the Library's occupancy.

- e. Final invoice.
